**Northwoods Humane Society reserves the right to refuse adoption service to anyone. If we believe it is not in the best interests of an animal, we have sole discretion to deny your adoption application or hold it for twenty-four (24) hours for further review.**

Northwoods Humane Society ("Northwoods") agrees to place and Adopter agrees to adopt the following animal ("Animal") according to the terms and conditions stated below:

Adopter agrees to provide this Animal with proper food, water, veterinary care, identification, training, and loving attention.

1. Adopter agrees that Northwoods has limited, if any, knowledge of the Animal's previous environment, and therefore is not responsible for the health or temperament of this Animal.
2. Adopter agrees that Adopter will bring no claim or action against Northwoods, its officers or agents in connection with this adoption; and once adopted, Adopter accepts full legal responsibility for this Animal and its actions.
3. Adopter agrees to comply with the laws and ordinances in the state and municipality in which Adopter resides regarding pet ownership and care.
4. Adopter agrees to not declaw the adopted cat within the thirty day trial period.
5. Adopter agrees that if at any time, Adopter is unable to keep or care for this Animal, Adopter will contact Northwoods about surrendering this Animal. Northwoods has sole discretion to work with the Adopter so the Animal can stay in Adopter's home or accept the Animal for surrender **depending on available shelter space.**
6. If within the thirty day trial period the Adopter decides the Animal is not the right match, the Adopter must first call Northwoods to schedule a time to bring the Animal back. The Adopter will then be provided with an exchange certificate which is valid for 6 months and is only good for the adoption of another animal of equal or lesser value (the difference will not be refunded if the full amount is not used).

\*\*\*Adopter agrees to have this Animal checked by a licensed veterinarian within seven (7) business days of the date of adoption.

- a. If the veterinarian finds a life threatening condition in this Animal that was present at the time of adoption, Adopter may choose to exchange this Animal for another of equal or lesser value. Documentation must be provided from the veterinarian and arrangements must be made to return the Animal within seven days from learning of the life threatening condition.
- b. If the veterinarian finds any issue concerning the Animal's health that requires treatment or medication, **call** a Northwoods staff member before incurring any medical expense; NHS can dispense certain medication (for NHS adopted animals only) if notified. **Adopter or veterinarian will not be reimbursed for any medical expenses.**

7. Adopter states that he/she has never been accused or convicted of animal abuse or neglect in Minnesota or any other state.
8. Adopter agrees to pay reasonable attorneys' fees and court costs should Northwoods pursue legal action for violations of this contract.
9. **NO CASH REFUNDS WILL BE GIVEN REGARDLESS OF CIRCUMSTANCES.**
